Montessori Schools of Irvine Parent/Staff Advisory Board meets quarterly. Plans were reviewed and approved at the meeting on 8/5/2020. Reopening plans approved and signed by parents on 8/6/2020. 100% of all parents surveyed support reopening in person.

Multiple Committee and Full Staff Meetings for input, planning and training occurred on 8/3, 8/5 and 8/6/2020. 100% of staff have signed acknowledgment and agreement of COVID Safety Plan. Ongoing review and updates with staff of plans and training continue which include updates from the Health Department as received.

II. Elementary School Reopening Plans

Cleaning and Disinfection: How shared surfaces will be regularly cleaned and disinfected and how use of shared items will be minimized.
